A typical factoring cash flow example (selling a business invoice for a cash advance) is presented below:

Your business factors an invoice for \$10,000 and you get a 90% (\$9000.00) advance. 10% (\$1000.00) is held in reserve by the lender. At the time that the invoice is paid, the transaction settles with a 3% (\$300.00) fee going to the factor (lender) and the balance of 7% (\$700.00) is placed into the factoring client's business account. In this example the total fee was 300.00 for factoring a \$10000.00 invoice.
